PROMOTIONAL PERIOD

1. The \$5,000 MEMBERS CASH SPLASH (Promotion) commences at 10am on Thursday April 11, 2019 and ends at 9.15pm after the last draw on Thursday August 29, 2019.

ELIGIBILITY

2. Promotion is open to all financial members of The Randwick Club Group.
3. Members must be present at The Randwick Bowling Club, Cnr The Avenue & Cowper Streets Randwick at the time of draw to claim the prize and have four (4) minutes to make themselves known to the promotional representative and produce their Randwick Club Membership Card in order to claim their prize.

PROCESS

4. Members received one (1) entry for every \$5 bar purchase and are invited to place their ticket/s in a barrel in the Bowling Club before 6pm on any draw night.
5. There are three (3) draws each Thursday night week at 6pm, 7pm and 8pm.
6. The \$5000 MEMBERS CASH SPLASH prize pool starts at \$250 cash. The prize pool jackpots by \$250 each week if the prize is not claimed in any of the three draws on that night.
7. When The \$5000 MEMBERS CASH SPLASH JACKPOT prize is claimed, there will be no further draws conducted during that night. The prize pool reverts to the start-up figure of \$250 the following Thursday- seven days from the date the prize is claimed.
8. The entry barrel will be emptied after the \$5,000 MEMBERS CASH SPLASH JACKPOT prize has been won.
